RENTAL RESERVATIONS

All of our rentals are made by reservation. We require a minimum of 2 weeks out from your event. Orders made in under a week will be charged rush fee. Mnimum of \$250 rental order for delervies. Minimum of \$150 for customer pick-up's.

INSURANCE FEE / DAMAGE WAIVER CHARGE (DWC)

The DWC protects both parties. It is 12% of the total rental rate of your contract. The DWC relieves the customer of any accidental damage to the rented item(s) within your contract and for loss due

to fire, collision, windstorm, upset and riot. We exclude from this waiver, however, any loss or damage due to theft, burglary, misuse or abuse, theft by conversion, intentional damage, mysterious disappearance or other loss due to your failure to care for the rented item(s). This is a non-negotiable and non-refundable fee. Exception to this is as follows: Lessee represents and warrants that Lessee has insurance against liability for injury to person and property in amounts equal to or


